1. Instruction:

Amendment:

The school strictly prescribes only NCERT books for academic instruction. The school has not provided any book list to any bookseller/vendor for the purchase of additional books.

Furthermore, two optional supplementary learning resources that were earlier displayed on the website with the notation 'Not Compulsory' have now been removed

that were previously uploaded on the website with the note "(Not Compulsory)" have now been completely removed, and the revised fully compliant book list has been updated on the school website.

Teachers regularly utilise their own reference material, worksheets, classroom notes, digital resources, and school-prepared academic material for effective teaching-learning purposes in the interest of students. Parents and students are not subjected to any pressure or compulsion for purchasing any particular book or study material.

The school does not indulge in any unfair trade practices. Parents are neither compelled nor directed to purchase books, uniforms, stationery, or any other material from any specific vendor or shop. In cases where parents seek assistance regarding availability, the school may only provide general guidance regarding nearby vendors purely for convenience purposes.

2. Instruction:

As per the information available with the school, no student has purchased the said optional material. The school remains committed to complying with all directions issued by the competent authorities."

4. Instruction:
